TRLA ATTORNEY AT FJC RECEIVES ACHIEVEMENT AWARD

Texas Rio Grande Legal Aid's, Legal Assistance to Rural Shelters (LARS) recently awarded Kristine Cuello with its Achievement Award. Kristine was recognized for



her outstanding commitment to justice and her contributions to helping end domestic violence and sexual assault. Kristine has accepted the most pro bono and reduced fee cases from TRLA's office at the Bexar County Family Justice Center.
