

At a Glance in FY 2004

(October 1, 2003 through September 30, 2004)

Trained 795 law enforcement officers, prosecutors, dispatchers and advocates at 22 trainings, reaching 106,800–445,000¹ victims of domestic and sexual violence and 985² secondary students through the *Domestic Violence: Train-the-Trainer Program* with the Federal Law Enforcement Training Center; the *Rural Law Enforcement Training – Domestic Violence: Intervention and Investigation* and *Rural Domestic Violence Training for Communication Professionals (Dispatchers/Call Takers)* with the National Sheriffs' Association; and the *Rural Sexual Assault Management and Investigators Conferences* with the National Center for Rural Law Enforcement – *funded by the Office on Violence Against Women*

Developed and presented 3 trainings reaching 300 Coast Guard commanders, 50 Air Force Judge Advocate Generals, reaching 600–3,000³ victims of domestic violence, and 44 chaplains from all military services, reaching 2,640–52,800⁴ victims of domestic violence

Trained 131 military and civilian law enforcement officers, prosecutors and advocates at 4 trainings, reaching 47,160–393,000⁵ victims of domestic violence and 655⁶ secondary students through the *Domestic Violence:* Train-the-Trainer Program, with the Federal Law Enforcement Training Center – funded by the Office on Violence Against Women and the U.S. Department of Defense

Developed and presented 20 customized trainings on a variety of topics for diverse audiences nationwide

Provided logistical and meeting planning support and onsite consultation for 94 meetings and trainings through the Technical Assistance Providers Support (TAPS) project – funded by the Office on Violence Against Women

Participated in 4 meetings to support the implementation processes for the recommendations of the Defense Task Force on Domestic Violence and the Task Force for the Care of Victims of Sexual Assault

Testified 3 times before the U.S. Senate and House of Representatives and the Congressional Women's Caucus

Launched the Military/Civilian Coordinated Community Response Demonstration Project with the Battered Women's Justice Project in Jacksonville, FL, and their naval stations, JAX and Mayport, and the Army's Fort Campbell, KY-funded by the Office on Violence Against Women and the U.S. Department of Defense

Consulted with 8 communities and organizations in their response to domestic and sexual violence; participated in 17 networking and planning meetings; and attended 28 professional development trainings

Responded to **683** technical assistance requests; added **2,724** books, videos, reports and manuals to the library – *funded by the Office on Violence Against Women*

Received the 2004 Standard of Excellence Award in September 2004 from the Web Marketing Association. The National Center's website received 3,483,457 visits in FY 2004.

¹ Estimates each officer from a rural area responds to five calls a month (60 per year), while those from urban areas respond to as many as five a week (250 per year).

² Estimates each train-the-trainer participant trains at least five others; the impact may be much greater.

³ Estimates each JAG from a small base talks to one victim a month, while those from larger bases talk to five a month.

⁴ Estimates each chaplain from a small installation talks to five victims a month (60 per year), while those from larger installations talk with as many as 100 a month (1,200 per year).

⁵ Estimates each officer from a small installation/community responds to five calls a month (60 per year), while those from larger installations/more urban areas may respond to as many as 10 per week (500 per year).
