Impacting Families Across Ohio...

ODVN is making progress for families through statewide collaboration and outreach. One of our stellar programs in 2012 was the launching of the Ohio Men's Action Network (OH-MAN). As a network of concerned and caring men and women, they are working diligently to engage and support men and boys to take an active role in efforts to prevent all forms of violence against women.



OH-MAN seeks to create communities where everyone can live free of violence and share a commitment of respect, safety and equality in their relationships.

A joint project of ODVN and the Ohio Alliance to End Sexual Violence, OH-MAN created a special website to provide a structure to identify and create resources, share and learn from one another, and increase the capacity of local programs in engaging men and boys in prevention. Protecting Endangered Children...

A critical goal for ODVN is to improve the safety and well-being of children exposed to domestic violence. The Family Systems Advocacy Program at ODVN provides a two-pronged approach to effecting positive changes in family-serving organizations at the state and local level. We are partnering with the Ohio Intimate Partner Violence Collaborative in the Ohio Department of Job and Family Services, the Supreme Court of Ohio, the National Center on Adoption Law and



Policy, the Healthpath Foundation and multidisciplinary professionals from across Ohio. Together, we are working to improve the response to domestic violence for families involved with Children's Protective Services through the development of a new statewide model program.

ODVN currently provides special training and technical assistance to enhance the domestic violence competency of local public children's services agencies and to encourage the development of agency partnerships with local domestic violence programs. The ODVN Family Systems Advocacy Director has developed and tested a comprehensive community readiness assessment that serves as a locally adaptable tool for preparing and planning community-based initiatives to improve responses to families and children impacted by domestic violence.

Linking with Lawyers to Help Survivors...



ODVN is making progress by partnering with attorneys throughout Ohio, offering civil legal assistance to survivors of domestic violence, sexual assault and stalking. Help is extended to survivors who have a low income and are not eligible for legal assistance through other resources in Ohio. In 2012, a total of 429 survivors accessed legal assistance for a wide range of needs including: divorce, custody, visitation, child support, housing issues, consumer issues, employment issues, immigration and civil protection orders. We heard from many survivors that, without the support of their ODVN-

provided attorney, they would have faced their abusers alone in court. ODVN applauds the 57 attorneys who last year provided reduced fee or pro bono assistance in domestic violence civil cases. They tell us that this is among the most important work they do in their law practices.

Keeping Family Pets Safe...

ODVN is making progress by ensuring that the pets of victims of domestic violence are safe. Critical Statistic: 68% of survivors in domestic violence shelters reported violence towards their animals. A total of 87% of these incidents occurred in the presence of the victims and 75% in the presence of children.

Through a funding partnership with the Kenneth A. Scott Charitable Trust, a KeyBank Trust, ODVN's Domestic Violence Program Guide to Pet Support was developed and produced in 2012. This important manual offers practical information and specific guidelines for domestic violence shelters regarding accessing off-site housing for shelter residents' pets. Materials available on

ODVN's website include sample Memos of Understanding (MOUs) between animal shelters and domestic violence shelters, contracts between foster families and pet owners, and safety planning for pets. For example, The Happy Trails Farm Animal Sanctuary in Ravenna, Ohio, last year initiated a new partnership with ODVN. "Barns of Love" is a unique program designed to provide foster care for farm animals at risk in domestic violence situations.



Training for Trauma Informed Care...

ODVN is making progress on the local level by improving the effectiveness of advocates and agency programs. In 2012, ODVN offered 125 trainings providing new knowledge and skills to over 3,500 people. During 2012, we focused on providing specialized training and technical assistance on building awareness of and promoting the implementation of trauma-informed practices. Chronic traumatic situations such as domestic violence are those that occur repeatedly over time. These experiences trigger a range of responses including intense fear, a loss of trust in others, a decreasing sense of personnel safety, helplessness and a loss of control.

"What is critical to understanding trauma is that traumatic responses are a NORMAL reaction to ABNORMAL events. Anyone can experience traumatic responses if they experience a traumatic event. Trauma-informed practices are not a specific type of service, but rather a set of principles that place trauma at the center of our understanding of domestic violence survivors," says Rachel Ramirez, ODVN Training Coordinator.

Building on ODVN's ground-breaking manual, Trauma Informed Care: Best Practices and Protocol for Ohio's Domestic Violence Programs, we increased the effectiveness of advocates in Ohio's domestic violence programs by providing state-of-the-art skills-focused training. During 2012, we assisted programs throughout the country and conducted trainings in California, Florida, Pennsylvania, and Minnesota.

Ensuring Safety for All Survivors...

ODVN is making progress by ensuring our programs are safe and welcoming to all survivors... regardless of their race, gender, age or sexual orientation.

In collaboration with the Ohio Alliance to End Sexual Violence, the Buckeye Region Anti-Violence Organization (BRAVO), and the ODVN LGBTQ Task Force, we initiated the Safe Zone Project. The Safe Zone Project expands the capacity of domestic violence



agencies to provide culturally competent services to the LGBTQ community. The training and technical assistance is designed for an agency to holistically reflect on their assumptions and belief systems and revise policies, procedures, and outreach efforts for this community.

Making a National Impact...

ODVN is making progress by partnering with several national initiatives.



Collaborating closely with partners across the country, including: the National Network to End Domestic Violence, and the National Task Force to End Sexual and Domestic Violence Against Women, ODVN and our member programs worked tirelessly to secure passage of the reauthorization of the Violence Against Women Act (VAWA).

Since its original passage in 1994, VAWA has dramatically enhanced our nation's efforts to address domestic violence, sexual violence, dating violence and stalking. Comprehensive

programs at the state and local level reduce violence, protect lives, hold perpetrators accountable, and save money. VAWA saved nearly \$12.6 billion in net averted social costs since its initial passage in 1994 according to studies conducted by the Department of Justice. The reauthorization of VAWA lead to significant improvements in safety and accountability for Native American and LGBTQ survivors.

The National Intimate Partner Prevention Council was formed in 2012 by state domestic violence coalitions and national partners to advance a comprehensive national prevention agenda, build leadership, and enhance the capacity of domestic violence programs to engage in effective and sustainable primary prevention and collaborate with national partners around prevention efforts that intersect with intimate partner violence. The immediate goals of the Council are to develop tools and resources that promote evidenced-based practice in prevention and disseminate them through technology and social media. ODVN is proud to have Rebecca Cline, Prevention Programs Director, elected to serve on the inaugural board.






