Calculate ROI for Attendance- How to Justify Conference Attendance

Conference expenses are affected by a number of factors. Before you can even begin to justify conference expenses, you need to calculate what those expenses are. To do so, use the following Expenses Worksheet to develop a cost estimate for attending Vet Court Con.

Lodging	Justice For Vets negotiated rates with hotel	\$
Transportation: Airport to Hotel	Taxi- car rental?	\$
Transportation: Hotel to Airport	Taxi- car rental?	\$
Mileage Reimbursement	Driving to conference? To the airport for your flight? Use Map Quest to calculate distances, then multiply miles by 55.5 cents/mile (IRS standard for 2012)	\$
Parking Reimbursement	at airport for flight departure, or at hotel where conference is located	\$
Food Per Diem	IRS local rate for conference is \$71. Remember, most include breakfast \$12, lunch \$18, Dinner \$36 & incidentals \$5	\$
